I, and on behalf of the MPs of the Republic of Yemen in Sana'a, send our best regards to you and wish you all success in your work, and we would like to inform you that the brutal aggression and the unjust blockade on Yemen by land, sea and air by the countries of the coalition led by Saudi Arabia and the UAE since March 2015 have led to the death of tens of thousands of Yemeni citizens as a result of the massacres committed by the coalition, the latest of which was the crime that occurred in Washeha district, Hajjah Governorate which killed ten children and women from one family and wounded two others, and destroyed the infrastructure and all the capabilities of Yemen. The Yemeni people have become living the largest humanitarian catastrophe in the world, especially after the spread of the Corona virus in full view of the international community, the Security Council, the United Nations, and international and regional human rights bodies.

Moreover, Yemen not only suffered from unjust aggression and suffocating blockade, but also suffered from occupation under the pretext of liberation which seeks to disrupt Yemen's unity and social fabric and loot its wealth. This is clearly evidenced by the practices of Saudi Arabia and the United Arab Emirates on Socotra Island, Mahra Governorate, and other areas and islands under the control of the coalition countries that claim to liberate them.
